To the residents of the "Kreuzberg-Luisenstadt" study area

survey concerning the social preservation ordinance

Dear residents,

since 2017, a social preservation ordinance (also known as "milieu protection", German: "Milieuschutz") has existed for the residential areas north and south of the Skalitzer Straße under the name "Kreuzberg-Luisenstadt". Due to the existence of this ordinance, the district administration of Friedrichshain-Kreuzberg is permitted to regulate the modernization of apartments more strictly. By doing so, the district office tries to enforce that modernization measures are carried out in a socially acceptable manner and that the modernization of apartments does not result in the rapid change of the local social structure due to the displacement of inhabitants.

In order for a social preservation ordinance to be applied, certain requirements must be met. These requirements must be reviewed periodically to assess whether a social preservation ordinance is still permissible for the area. The urban planning office of Friedrichshain-Kreuzberg has commissioned the urban research agency asum GmbH to conduct such a review. Additionally, the asum GmbH will assess whether certain living blocks outside of the current social preservation area (see block 24 and block 25 on the provided map) fulfil the requirements to be integrated into the social preservation ordinance "Kreuzberg-Luisenstadt".

In order to obtain the necessary information, randomly selected households in your residential area are asked to take part in a survey. Participation in the survey is voluntary. The asum GmbH is obliged to evaluate your answers anonymously and to comply with the data protection rules of the district of Friedrichshain-Kreuzberg and the state of Berlin.

Please DO NOT send in the printed version of the questionnaire if you have already successfully participated in the online survey.
